I. Definitions:

For the purposes of this document:

- 1. "Rights Holder" means the person whose image is to be disseminated or who has the right to the image to be disseminated.

We work on business days from Monday to Friday from 07:00 to 15:00 hrs.
- 3. "Image Dissemination" means making the image publicly available, without time or territorial limitation, as part of a Photograph, in any manner, including in printed and electronic form, as well as making the Photograph publicly available in such a manner that everyone can have access to it in the place and at the time of their choice (in particular any websites, press, promotional and informational materials).
- 4. "Image Use" means manners of using the image other than Image Dissemination, to the extent necessary to prepare a Photograph and Image Dissemination, without time or territorial limitation, including (i) recording the image on any medium, including in electronic form (ii) reproduction of the image so recorded, (iii) storage of the image so recorded, (iv) recording on any medium, including in electronic form, any Photographs of which the image is an element, (v) reproduction of the Photograph so recorded, (vi) storage of the Photograph so recorded.
- 5. "Image Disposal" means Image Dissemination and Image Use. Image Disposal is valid without any time or territorial limitation.
- 6. "Image Disposal Purpose" means (1) preparation of a Photograph and (2) publication and dissemination of the Photograph in Lerg Spółka Akcyjna's materials, including promotional and informational materials (3) making Photographs of which the image is an element publicly available for the purpose of advertising, promotion and marketing of Lerg Spółka Akcyjna, save that such making publicly available may occur in any manner, including where an unlimited number of unspecified entities have access to Photographs, including, but not limited to, by (i) making Photographs available on Lerg Spółka Akcyjna's website, on another website or on a social networking site, (ii) placing on the market, whether for remuneration or otherwise, any media (e.g. DVDs) on which

Photographs have been recorded, together with the image, (iii) disclosing in the press, (iv) disclosing in publicly available promotional and informational materials of Lerg Spółka Akcyjna.

- 7. GDPR means Regulation (EU) No 2016/679 of the European Parliament and of the Council of 27 April 2016 on the protection of natural persons with regard to the processing of personal data and on the free movement of such data, and repealing Directive 95/46/EC (General Data Protection Regulation), (OJ EU L 119/1).
- 8. "Personal Data" means information concerning an identified or identifiable natural person.
- 9. "Personal Data Processing" means data processing within the meaning of Article 4 (2) GDPR, i.e. the processing by the Processor (or as appropriate by natural persons employed by the Processor) of any operations on the personal data transferred for processing in an automated or non-automated manner, such as collecting, recording, organizing, structuring, storing, adapting or modifying, downloading, viewing, using, disclosing by sending, distributing or other type of sharing, matching or combining, restricting, erasing or destroying, especially those that are performed in the Information System.
- 10. "Controller" means an authority, institution, organizational unit, entity or person deciding on the purposes and means of Personal Data Processing, meeting the conditions for being considered a "Controller" in accordance with the provisions of the GDPR.
- 11. "Processor" means a natural or legal person, public authority, unit or other entity that processes personal data on behalf of the Controller.
- 12. "Personnel" means employees, members of management and supervisory bodies, associates and subcontractors of the Processor who will directly perform the obligations of the Processor arising from this Agreement.

II. Statements of the Rights Holder.

- 1. The Rights Holder agrees that by granting this consent they consent to the Rights Holder's Image Disposal by Lerg Spółka Akcyjna in accordance with the Image Disposal Purpose. In particular, the User acknowledges that the Image Disposal may occur at any time after the submission of this statement and in any country, save that Lerg Spółka Akcyjna is in no manner obliged to dispose of the Image.
- 2. The Rights Holder agrees that Lerg Spółka Akcyjna may authorize another entity to perform the Rights Holder's Image Disposal in accordance with the Image Disposal Purpose (e.g. an entity that prepares Photographs), in whole or in part, and in this respect the Rights Holder also acknowledges that by granting the this consent they consent to the same.
- 3. The Rights Holder agrees that as part of the Rights Holder's Image Disposal in accordance with the Image Disposal Purpose, the Rights Holder's image may be combined with or may appear next to photos, texts, characters and other elements of Photographs, as well as other content, including comments, audiovisual works, videograms, phonograms or any other manifestations of human activity other than works which are or may be available besides Photographs (e.g. on Lerg Spółka Akcyjna's website), as well as that any recordings of the Rights Holder's image may be changed, to the extent necessary to prepare a Photograph or the Image Disposal, save that the Rights Holder will not be obliged or entitled to accept the final result of the same, and in this respect the Rights Holder also acknowledges that by granting this consent they consent to the same.
- 4. The Rights Holder agrees that by granting this consent they represent and warrant that they are the sole holder of the rights to the image, including all titles in the image, and that there are no factual or legal circumstances that

would prevent Lerg Spółka Akcyjna from properly performing the obligations of the Rights Holder under this statement or the Rights Holder's Image Disposal in accordance with the Image Disposal Purpose, including that they have not concluded any image-related agreements, in particular agreements under which the Rights Holder would authorize another entity to use the image of the Rights Holder on an exclusivity basis.

- 5. The Rights Holder acknowledges that by granting this consent to the Rights Holder's Image Disposal by Lerg Spółka Akcyjna in accordance with the Image Disposal Purpose they do not acquire any rights to demand any remuneration.
- 6. The Rights Holder agrees that this statement in no manner limits or excludes Lerg Spółka Akcyjna's right to disseminate the Rights Holder's image in cases and to the extent provided for by law, including where Lerg Spółka Akcyjna disseminates the Rights Holder's image as a person being a detail of a larger whole.
- 7. The Rights Holder agrees that any changes or amendments to the Rights Holder's statement must be made in writing to be valid.
- 8. The Rights Holder agrees that in the case that any part of the Rights Holder's statement is considered to be invalid, it is assumed that the Rights Holder's statement continues to be binding as a whole and that in replacement of a provision so considered invalid, valid provisions will be introduced, which in their wording are the closest to the provisions considered to be invalid. This provision applies accordingly to ineffectiveness.
- 9. The Rights Holder agrees that this statement also applies to those cases in which Lerg Spółka Akcyjna has started the Rights Holder's Image Disposal or has performed the Rights Holder's Image Disposal in in accordance with the Image Disposal Purpose before the date of this statement.
- 10. The Rights Holder agrees that this statement applies to every case of the Rights Holder's Image Disposal by Lerg Spółka Akcyjna in accordance with the Image Disposal Purpose.

III. Information regarding personal data processing for the image.

According to Article 13 (1) and (2) GDPR, please be advised that:

- 2. Your personal data for the image will be processed in accordance with the GDPR for the purposes of marketing, information, promotional and advertising activities of the Controller, including online, on the Controller's website in its bulletin, and in printed materials such as company newsletter, leaflets, catalogues, company catalogue and other advertising and promotional materials of the Controller based on your consent pursuant to Article 6 (1) (a) GDPR.

- 5. You have the right to request the Controller to provide you with access to your personal data, rectify it, delete it, limit processing and transfer the data.

- 6. You have the right to withdraw your given consent at any time by sending a statement of withdrawal of consent to the e-mail address: lerg@lerg.pl, without affecting the lawfulness of the processing that was carried out on the basis of consent before its withdrawal.
- 7. You have the right to complain against the Controller's activities to the President of the Office for Personal Data Protection, ul. Stawki 2, 00-193 Warsaw
- 8. Providing personal data referred to in item 2 above is voluntary and is not a statutory or contractual requirement or a condition of concluding the contract, however, the consequence of not providing personal data is the inability to use your image.
- 9. No actions will be taken in relation to you, which would involve automated decision making, including profiling.
